## POTOMAC RIDGE INDIVIDUAL MEMBERSHIP CONTRACT

This Membership Contract (the "Agreement") is entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 2008 by you, the individual identified on the Potomac Ridge Member Enrollment Form.

### EXPLANATORY NOTE

Atlantic Golf, L.P., a Maryland limited partnership with a principal business address of 3168 Braverton Street, Suite 400, Edgewater, MD 21037 ("Atlantic Golf"), owns and operates several privately owned, daily-fee golf courses. Member desires an opportunity to enjoy Potomac Ridge's facilities at 15800 Sharperville Road, Waldorf, MD 21601 ("Potomac Ridge") on a regular basis and obtain certain privileges associated with being identified as a member of Potomac Ridge. Member agrees to become a Member on the terms and conditions set forth herein.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Member agrees as follows:

1. **MEMBER:** For purposes of this Agreement, "Member" shall mean the person identified on the "Potomac Ridge Individual Member Enrollment Form".
2. **MEMBERSHIP.** Upon payment of Membership Fee (defined in Section 4), Member's membership privileges will be activated for a period of twelve (12) continuous months ("Membership Term"). Memberships may be refused or revoked at the discretion of Potomac Ridge. Membership Fee is neither refundable nor transferable. Payment of Membership Fee does not give Member any right, interest or ownership in Potomac Ridge. Members must present their membership card each visit. Membership privileges are personal to Member and may not be sold, transferred, or otherwise assigned in any manner. Privileges shall cease and terminate upon the death of Member. Potomac Ridge may revoke membership if Member violates any terms of this contract agreement. No portion of any fees paid is refundable upon revocation or suspension of a membership, other than as set forth in Section 14 below.
3. **MEMBER PRIVILEGES.** For the duration of the Membership Term, Member will receive certain benefits which vary and are dependant upon the type of membership elected under Section 4 below. Collectively, these benefits are referred to as "Member Privileges" Potomac Ridge reserves the right to modify Member Privileges at any time by providing written notice in accordance with Section 18 below.
4. **MEMBERSHIP TYPES, MEMBERSHIP PRIVILEGES AND MEMBERSHIP FEES.** Potomac Ridge offers one (1) type of membership, with a corresponding annual fee (the "Membership Fee"). (*Member is to initial after type of membership selected.*)
  - A. **Potomac Ridge Membership.** A "Potomac Ridge" Membership is a membership providing all of the following Membership Privileges exclusively at Potomac Ridge (7) days a week: Complimentary greens fees, complimentary use of golf cart, complimentary use of driving range, complimentary USGA® Handicap Service, 20% discount on all regularly priced merchandise in Potomac Ridge's Pro Shop, invitations to Member tournaments and events, Member shirt, and 20% discount on non-twilight greens fees for up to three (3) accompanied guests per visit. This membership will not be subject to the weekend surcharge. In the event that Potomac Ridge is closed on member's choice day to play, member will be permitted to play one of Atlantic Golf's other courses (Queenstown River, Queenstown Lakes or South River). For privilege and billing purposes, Member shall be referred to as a Potomac Ridge Member. The Fee for one Potomac Ridge Membership is \$2,700.00 annually. \_\_\_\_\_

- B. **Additional Potomac Ridge Membership.** An “Additional Potomac Ridge” Membership is an add-on membership where the Member is a spouse, parent, child or same-sex partner of the primary Member. Additional Potomac Ridge Member must permanently reside in the same primary residence as the Potomac Ridge Member and Potomac Ridge will require strict proof of primary residence before accepting an Additional Potomac Ridge Membership. Additional Potomac Ridge Membership provides the same privileges as the Potomac Ridge Membership. Member shall be referred to as an Additional Potomac Ridge Member. The Fee for one Additional Potomac Ridge Membership is \$2,500.00 annually. \_\_\_\_\_
  
- C. **Potomac Ridge Twilight Membership.** A “Potomac Ridge Twilight Membership” is a restricted membership which provides all of the following Membership Privileges at Potomac Ridge, solely during posted twilight hours: complimentary greens fees, complimentary use of golf cart and complimentary use of driving range. For purposes of this Agreement, the term “twilight” shall mean the time of the day when the rates change at Atlantic Golf facilities. The exact time of “twilight” changes seasonally and is regularly posted and updated on Atlantic Golf’s website and at the pro shop for each Atlantic Golf facility. Membership Privileges also include complimentary USGA® Handicap Service, Member shirt, 20% discount on all regularly priced merchandise in Atlantic Golf’s Pro Shop and invitations to Member tournaments and events. In the event that Potomac Ridge is closed on member’s choice day to play, member will be permitted to play one of Atlantic Golf’s other courses (Queenstown River, Queenstown Lakes or South River). For privilege and billing purposes, Member shall be referred to as a Potomac Ridge Twilight Member. The Fee for one Potomac Ridge Twilight membership is \$1,700.00 annually. \_\_\_\_\_
  
- D. **Additional Potomac Ridge Twilight Membership.** An “Additional Potomac Ridge Twilight Membership” is an add-on restricted membership where the member is a spouse, parent, child or same-sex partner of a Potomac Ridge Twilight Member. Additional Potomac Ridge Twilight Member must permanently reside in the same primary residence as the Twilight Member and Atlantic Golf will require strict proof of primary residence before accepting Additional Potomac Ridge Twilight Membership. Additional Potomac Ridge Twilight Membership provides all benefits of a Potomac Ridge Twilight Membership. For privilege and billing purposes, Member shall be referred to as an Additional Potomac Ridge Twilight Member. The Fee for one Additional Twilight Membership is \$1,500.00 annually. \_\_\_\_\_
  
- E. **Potomac Ridge Junior Membership.** A “Potomac Ridge Junior Membership” is a full membership where the sole primary member is a minor (under the age of eighteen). A Potomac Ridge Junior Membership provides the following Membership Privileges at Potomac Ridge: Complimentary greens fees on weekdays, complimentary greens fees on Saturdays, Sundays and holidays after 1pm, 50% discount on greens fees on Saturdays, Sundays and holidays before 1pm, complimentary use of golf cart, complimentary use of driving range, complimentary USGA® Handicap Service, and invitations to Member tournaments and events. Membership contract is between Atlantic Golf and parent or guardian of minor. Membership provides full membership privileges to minor. For privilege and billing purposes, Member shall be referred to as a Potomac Ridge Junior Member. The Fee for one Junior Membership is \$750.00 annually. \_\_\_\_\_

Notwithstanding the foregoing recitation of membership types and fees, Potomac Ridge reserves the right to offer other memberships and membership specials from time to time.

**5. PAYMENT OF MEMBERSHIP FEES AND OTHER FEES.**

- A. Member Account. Member has option to have a Member Account. Member shall complete Exhibit A – Credit Card Enrollment Authorization Form to open account.

B. Charge Privileges. Member may have charge privileges in the café, pro shop and mobile beverage carts as long as a valid credit card and authorizing signature is on file in Member Account with Potomac Ridge. Members must present their membership card at the time of charged purchases and should write their member number and signature on each sales ticket for charged purchases ("Charges"). Member may not authorize dependant children to exercise charge privileges to Member's Account.

C. Posting. Member will be provided an itemized accounting on the 1<sup>st</sup> of the month for all Greens Fees, Guest Fees, Cancellation Fees and Charges to Member's Account for the preceding month. Unless Member provides Notice within fifteen (15) calendar days (in accordance with Section 18 below) that it disputes a Charge to the Member's Account, all Charges will be billed to Member's credit card on the 17th of the calendar month. In the event that the charge is declined, Potomac Ridge will resubmit the charge within five (5) business days. In the event that the charge is declined again, Potomac Ridge will immediately notify Member and demand payment for unpaid account. Member must satisfy demand for payment of unpaid account within ten (10) business days. Failure to satisfy a demand for payment of declined charges will result in the suspension of membership privileges until payment is made in full. Such failure may also be grounds for membership termination at the discretion of Potomac Ridge.

D. Non-payment and Collections. Members agree to pay all amounts when due. Amounts more than thirty (30) days overdue will accrue a finance charge of 1.5% each month. Members agree to pay all reasonable attorney fees and costs incurred by Potomac Ridge in the event that collection proceedings are undertaken to obtain monies owed to Potomac Ridge.

**6. COMPLIANCE.** Member agrees to abide by Potomac Ridge's general policies as set forth herein and as may be published by Potomac Ridge from time to time. Potomac Ridge believes that golf is a game and expects Members to assist Potomac Ridge in keeping golf fun for everyone. Accordingly, Potomac Ridge expects all Members and guests to observe all federal, state and local laws at all times. Members must check in with the golf shop staff before proceeding to any course, driving range, practice area or other facilities. No alcohol may be brought onto Potomac Ridge premises for consumption. The only alcohol to be consumed on site is alcohol purchased on site. No underage drinking is permitted. Any damage to the golf course and property is the responsibility of the golfer to repair or replace. Potomac Ridge reserves the right to expel any golfer who uses excessive foul language, illegal substances or exhibits aggressive or violent behavior. **Children under the age of 16 are welcome on the golf course and in the clubhouse when accompanied by an adult, unless the general manager, head golf professional, or director of instruction has granted permission for an unaccompanied visit in advance.**

**7. RESERVATIONS.** For groups of 2 – 8 players, Potomac Ridge will reserve Member's tee times for up to thirty-five (35) days in advance. For groups of 9 players or more, Member must contact the Events Department for tee times. All Members or groups of 9 or more players will be subject to regular greens fees. Single Members may walk on after checking in with golf shop staff. To maintain the integrity of play administration, all Members and their guests, if any, must register in the golf shop at least 10 minutes prior to a reserved starting time. Failure to do so may result in a cancellation or delay if other parties are prepared to play or are on standby. Starting times not canceled at least twenty-four (24) hours in advance of play will be billed to Member Account at the regular posted greens fees for each player reserved.

**8. MEDIA RELEASE.** From time to time, Potomac Ridge may publish photographs on its websites or marketing materials. You hereby give Potomac Ridge, its successors and assigns, the right and permission to publish or post, for art, advertising trade or any other lawful purpose whatsoever, your name, photograph and/or likeness. You release, discharge, and agree to save Potomac Ridge, its successors, officers, directors, employees, and agents from any liability in connection with the publication of any photograph or information pertaining to Member. Member waives any right to inspect and/or approve the finished product and printed matter that may be used in connection therewith, or the use to which it may be applied.

**9. AVAILABILITY OF FACILITIES.** Potomac Ridge reserves the right to host special events such as weddings, parties, and golf tournaments. Such events may partially restrict the availability of golf course starting

times and any or all of the practice areas. Such special events also may preclude the use of the clubhouse. Any or all practice areas also may be unavailable from time to time because of inclement weather or maintenance practices. Potomac Ridge reserves the right to close the golf course and facilities for any reason in its sole discretion.

**10. GUEST POLICIES.** Members may host up to three accompanied guests at a rate of 20% off the regular posted rate for greens fees (the "Guest Fees"). All Guest Fees are payable at the time of play and may be charged to Member's Account. Guest Fees are not valid for tournaments or special events.

**11. USE OF GOLF CARTS.** As a rule, golf carts are allowed on the fairways, however, inclement weather or other conditions may evoke further cart restrictions. The golf staff will notify Members of any temporary restrictions, but players are expected to refrain from driving golf carts where it may damage the golf course. Privately owned golf carts are not allowed. No more than two carts per foursome are allowed unless authorized by the Pro Shop. No more than two riders and two golf bags per cart.

**12. PLAYERS CARD.** Member will be issued an Atlantic Golf players card ("Players Card") which accumulates points with each purchase made by Member. Membership Fees do not count toward points on Players Card. All other purchases, including up to three (3) Guest Fees per visit will accumulate Players Card points.

**14. EARLY TERMINATION OR SUSPENSION OF MEMBERSHIP.** In the event that Member (a) becomes disabled, sick or injured for a period exceeding thirty (30) continuous calendar days; (b) is activated for military service; or (c) is relocated for business more than (i) fifty (50) miles from the Potomac Ridge property and (ii) more than fifty (50) miles from Member's address set forth on the Member enrollment form, Potomac Ridge may suspend or terminate Member's membership. In the event of disability, injury or illness, Member must provide a doctor's note to Potomac Ridge. In the event of military service, Member must provide a copy of military orders from issuing authority. In the event of relocation, Member must provide a copy of a utility bill or other correspondence to demonstrate new domicile. In the event of termination, Potomac Ridge will issue Member a *pro rata* refund of Membership Fees. In the event of suspension, Potomac Ridge will not issue any refund, but will freeze membership for the suspension period. Potomac Ridge shall not be obligated to terminate or suspend a Member's membership. Decisions regarding early termination or suspension of membership will be in the sole and absolute discretion of Potomac Ridge.

**15. NO WARRANTY.** Potomac Ridge provides the Membership Privileges an "as is" basis, without warranty or guarantee of any kind, either express or implied, including, but not limited to, the implied warranties or

conditions of merchantability or fitness for a particular purpose. Some states do not allow the disclaimer of implied warranties, so the foregoing disclaimer may not apply to you.

**16. LIMITED LIABILITY.** In no event shall Potomac Ridge, its officers, employees or agents be liable for loss of any kind or for indirect, special or consequential damages of any kind, even if Potomac Ridge has been advised of the possibility of such damages arising from any defect or error. Member shall indemnify Potomac Ridge, its officers, employees and agents, and protect and hold Potomac Ridge, its officers, employees and agents harmless from and against any and all claims, liabilities, losses, costs, damages, expense, including consultants and attorneys' fees, court costs, demands, causes of action or judgment directly or indirectly arising out of or related to membership or Member's use of Membership Privileges. Potomac Ridge disclaims any and all loss or liability resulting from, but not limited to: acts of God, unauthorized use or misuse of your account information, errors, omissions or misstatements in any information or Membership Privileges provided under this Agreement or Member's inability to use Membership Privileges. Potomac Ridge's entire liability and that of its officers, employees, agents and any third party providing services as part of the Membership Privileges, and Member's exclusive remedy with respect to any matter arising out of this Agreement, is limited to the actual amount paid for Membership Fees.

**17. INDEMNIFICATION.** Member agrees to indemnify Potomac Ridge, its officers, employees and agents for any and all losses due to purposeful or negligent acts of Member, Member's guests, employees or children, including acts occurring as a result of the consumption of alcohol.

**18. NOTICE.** Any notice required or permitted by this Agreement shall be in writing and shall be deemed sufficient upon receipt, when delivered personally or by courier, overnight delivery service, confirmed facsimile, or forty-eight (48) hours after being deposited in the regular mail as certified or registered mail with postage prepaid. Any notices to Potomac Ridge shall be delivered to Atlantic Golf at the following address: Atlantic Golf, Limited Partnership, c/o The Brick Companies, 3168 Braverton Street, Suite 400, Edgewater, MD 21037, facsimile: (443) 951-2020, attn: Atlantic Golf Membership.

**19. GOVERNING LAW.** This Agreement shall be construed and governed in accordance with the laws of the State of Maryland, without giving effect to any principles of conflict of laws to the contrary.

I HEREBY CERTIFY AND REPRESENT THAT I AM OVER THE AGE OF 18 YEARS, HAVE READ AND FULLY UNDERSTAND ALL TERMS OF THE MEMBERSHIP CONTRACT AND I INTEND TO BE LEGALLY BOUND AGREE TO ABIDE BY ALL TERMS. THIS AGREEMENT REPRESENTS THE ENTIRE AGREEMENT AND SUPERSEDES ANY PRIOR AGREEMENT OR UNDERSTANDING CONCERNING THE SUBJECT MATTER HEREOF.
